HSCP 01/11 Notes of the previous meeting

Amendment to item 28/10, fourth sentence: "Local Involvement Networks (LINks) will 'evolve' into local HealthWatch organisations retaining the existing LINk functions whilst also developing the new additional HealthWatch functions". JB also gave the latest update: "HealthWatch England will be a direct subsidiary of the Care Quality Commission (CQC) and all local HealthWatch bodies will feed their recommendations into HealthWatch England if they do not get local satisfaction to the issues they raise. Also, if a local authority keeps their local Health Overview and Scrutiny Committee then they will no longer be overseen by CQC but will be assessed by peer-to-peer arrangements with other local authorities". Otherwise, the notes of the meeting held on 17th September 2010 were agreed.

Previous actions:

The circulated action sheet progress update was confirmed with additional comments noted:

09/10 – Market shaping approaches: JS confirmed ongoing consultation with various third sector providers, including 'micro providers', and will report back in due course.

10/10 – Social capital: VP referred to research, arising from prevention strategy work, which required further examination into evidence base. KN highlighted the 'Count Me In' approach. Micro providers could also provide information. With regard to the JSNA and how social capital can be measured (possible survey work) it was agreed to set up a Task and Finish Group. IT will lead and scope Terms of Reference to bring back to this group.

33/10 – Rural Health and Wellbeing Strategy: VP advised that this had been very well received by the Devon County Council Cabinet and will be revisited on an annual basis.

34/10 – Mental Health and Emotional Wellbeing Strategy: VP reported that positive feedback had been received from the Department of Health and that national strategy is due to be released in the near future.

30/10 – End of Life Strategy: YW referred to Senior Council for Devon meetings planned for 31st January and in February and requested an update on the consultation process.

Developing an action plan

Attention was drawn to the circulated briefing paper and a further briefing paper tabled by Roland Pyle (see Attachment 1 to minutes). Members were informed that the Devon Health and Wellbeing Board will be a formal local authority committee held in public with webcam access; published agenda, supporting papers and minutes. For clarification and reference purposes, copies of the NHS Devon Locality Profiles (December 2010) were distributed, containing details of the three Localities and seven GP Commissioning Consortia, ie North Locality (merged with the one GP Consortium to form the North Devon Locality Commissioning Board); Eastern Locality (four GP Consortia) and South Locality (two GP Consortia).

Discussion ensued on Annex 3; paragraphs 3.2 (planning and roll out and shadow Health and Wellbeing Board); 3.4 (proposed main functions); 3.10 (lead consortium representation) and Table 1 (early implementer key issues). Proposed core membership for Devon to include: GP Consortia; lay officer; Devon County Council Executive leader and another elected member; District leader and Chief Executive and contribution by Education. In relation to children's services and safeguarding children, the transition of Children's Trusts within the twelve months was highlighted and the need to maintain the profile of children, young people and families noted.

The following actions were agreed in relation to the proposed main functions of the Health and Wellbeing Boards, ie:

- 1) to assess the needs of the local population and lead the statutory Joint Strategic Needs Assessment;
- to promote integration and partnership across areas, including through promoting joined up commissioning plans across the NHS, social care and public health;
- 3) to support joint commissioning and pooled budget arrangements, where all parties agree this makes sense.
