#### 18/10 Welcome and Introductions

Jay Talbot welcomed members and introductions were made. Apologies were noted. The minutes of the last meeting on 29<sup>th</sup> April 2010 were agreed. Action points had been completed apart from those noted below.

# 19/10 Matters Arising Web Forum

The whole DSP communications system is being looked at, including updating the website and e – communications. A web forum will be discussed as part of this review.

### **Comprehensive Area Assessment**

The Coalition Government has abolished the CAA, so no further preparation will be needed.

#### **HSCP Conference**

Group members were reminded that the conference will be on 16<sup>th</sup> July.

#### 20/10 Public Spending and Demographic Change

Mark Gayler gave a presentation (slides attached) which showed graphically the impact of an ageing population on public services, alongside diminishing public spending.

The presentation led to a wide ranging discussion, taking into account the Coalition Government's Big Society agenda and the newly announced changes to the NHS. The following were the key points:

- The future role of the voluntary and community sectors (VCS)
- Current and future levels of public sector investment in VCS frontline and infrastructure
- The need to develop robust outcome based commissioning
- The impact of the 'personalisation' agenda
- Opportunities and threats for the local VCS
- VCS lever in a great deal of external funding to the county and provide employment and skills
- VCS and public sector need to develop new ways of working, based on new assessments of need
- The dangers of organisations retreating into silos due to funding cuts, when in fact there needs to be more collaboration
- Community action will be even more important
- VCS and social enterprise need to market themselves, and demonstrate what they
  can offer which is special.

#### 21/10 Improving Commissioning with the third Sector – IDeA programme

The meeting was informed about the forthcoming programme of joint facilitated workshops involving the VCS, NHS, Adult Services and Children and Young People's Services. These start in September. For more information contact Sue Craythorne.

#### 22/10 Healthy Weight Implementation Plan

Lucy O'Loughlin presented the plan and explained that local reference groups are being set up to monitor and challenge implementation. The work involves a balance between local action and centrally driven messages. Local Health and Wellbeing groups are engaging, and are conscious of the need to engage better with hard to reach groups. Links were noted with the Rural Health Strategy.

### 23/10 Public Health Locality Updates

Steady progress. A locality group is about to be set up in East Devon. All locality plans are more consistent in format and are now RAG rated. It was thanks to this that the local press picked up on the Exeter plan, which showed child obesity and teenage pregnancy as red rated - it was useful to raise awareness. In Mid Devon the District Council used their scrutiny processes to review the Health and Wellbeing plan.

There will shortly be new alcohol and service redesign strategies within the NHS.

### 24/10 Stronger Communities Programme Update

The summary performance report was presented to the group. It was agreed that it would be helpful to have a format which included reporting key activities during the period, and key successes, in addition to brining slippage to the attention of the group.

The meeting noted the progress being made in this first quarter of the programme.

# 25/10 Health Improvement Update

The Coalition Government was about to launch a consultation document on the future of public health, which is likely to transfer to local authorities. Ian Tearle will be preparing a briefing note which will be circulated.

- The Rural Health Strategy is out for consultation until early August.
