09/09 Welcome and Introduction

12/09 Rural Health Strategy

Ian Tearle introduced the draft plan which had been previously circulated. He thanked Sarah Tickner, who is working on the plan and indicated that it will be the SCHIG which will sign it off when finished.

The circulated document is an early draft and all comments and additional material, particularly actual evidence, will be welcomed by Sarah. <u>Sarah.tickner@nhs.net</u>

A wide ranging discussion ensued, and a summary of the key points follows:

- The strategy should be signed off by and badged as a DSP document, not just Health
- There are links to other work such as the recent Health Needs Assessment of migrant workers and Gypsies and Travellers
- Although the factors impacting on rural health are many, the strategy should concentrate on a few key issues, and not attempt to tackle everything. Pragmatism is the key.
- The strategy should include more reference to disability and its impact in rural areas.
- The group welcomed the document as a real attempt improve health and its determinants
- Links to local Health and Wellbeing groups and their priorities are essential. Rural housing issues are closely linked.
- The local LSPs need to own the document and use it to inform their activity. It should go on LSP agendas.
- We need to be opportunistic and use a variety of ways to promote this agenda through other projects and plans – eg Building Schools for the Future, Active Devon work
- Need input from farmers NFU
- Access to services and information is key links with other DSP work about this. Access is cropping up in almost all DSP theme groups.
- Much 'self help' activity which should be encouraged and supported eg community transport, social groups, clubs, community buildings etc and community volunteering
- ESSG is happy to provide equality scrutiny and an equality needs assessment must be done.
- Next steps are for a consultation draft to be ready by November for a 3 month consultation and likely finalising by April 2010

13/09 Stronger and Inclusive Communities Budget, delivery plan and projects

Sue Craythorne explained the background to the emerging delivery plan, stressing the fact that the research has been extensive over 2 years, mapping had been done and the proposed activities were aimed at filling gaps in provision. The only dedicated currently available budget is the one off £734,000 LPSA reward funding, due to be handed over to the County Council in December. Devon Consortium is finalising the proposals. Much is

also already happening and the group is keen not to duplicate, but to add to what is already going on.

Diana Crump and Karen Nolan talked about the activity areas which fall into 5 categories:

- Community hubs
- Service user engagement
- Community engagement and development
- Developing the third sector including volunteering support
- VCS representation on strategic groups

A prioritisation exercise is underway and a key factor will be the extent to which the work will help Devon achieve its LAA targets. It was agreed that whilst the statutory sector should be clearer about what it wishes to commission, the third sector should be proactive in using their knowledge to influence and evidence those priority areas.

One role of the SCHIG is to provide steerage in order to help all agencies to deliver their own, as well as partnership, priorities. Close links are also needed to the District based LSPs, to ensure that local action contributes to the overall objectives, and can be recorded and tracked.

Some group members felt they didn't have a full grasp of the content of the Consortium proposals. The latest iterations will be re-circulated.

Jill Borrow drew attention to the fact that there are external funding opportunities, often at short notice, which can help us all to meet objectives. For example the Active Villages initiative is aimed at bringing in volunteers, developing community engagement and helping rural people be more active. Active Devon has made a bid and has reached round 2. Neil Roberts will circulate the information.

The group shared difficulties of keeping track of all activity in the community engagement field, and the chair suggested setting up a web based forum to which we could all contribute. Sue Craythorne will look into it.

14/09 Public Health Update

Ian Tearle outlined the current public health strategies which were now in place. These are:

- Tobacco Control Strategy

There are many time limited multiagency partnerships in place to develop and act on these. All of these strategies will be brought to the group for sign off. Public health will also be consulting the other allied theme groups. Early sharing and input will be critical to success.

A web forum would also be useful for this purpose.
